The Biotechnology Graduate Program Board at Centro-Oeste Dona Lindu *Campus*, of the Federal University of São João del-Rei —UFSJ—, makes public, by this Call, the opening of the application, selection and enrollment processes for foreign, non-Brazilian resident candidates for the Biotechnology Doctorate Course, from the period of March 2020 to February 2024, observing the following aspects to be named as well as those contained in Resolution No. 042, of October 2, 2012 (Modified by Res. 035/2014), CONSU/UFSJ, available at the following web address:

1 VACANCIES

Art. 1 The total number of offered vacancies will be **02 (two) vacancies** linked to the advisers accredited by the Program and distributed according to **ANNEX I.**

2 APPLICATIONS

- **Art. 2** Applications will be held from September 19th to 20th, 2019.
- **Art. 3** The application must be exclusively done through electronic means, by e-mail (ppgbiotec@ufsj.edu.br), submitted to the Biotechnology Graduate Program Secretariat. The e-mail must be submitted by the final day of the application deadline, provided in Article 2 of this Call.
- **Arti. 4** At the time of application, the candidate shall submit the documentation described in Article 7. All documentation must be signed (when necessary) and digitized.
- **Art. 5** The <u>original</u> supporting documentation required for the application shall be presented <u>at the time of enrollment</u>, if the candidate is approved, together with the <u>Brazil residence visa and Travel Insurance</u>. Additional information may be obtained from the Program Secretariat by e-mail: <u>ppgbiotec@ufsj.edu.br</u>, or from the UFSJ Office of International Affairs by phone +55 (32) 3379 5812; e-mail: <u>assin@ufsj.edu.br</u>.

2.1 APPLICATION REQUIREMENTS

- **ART. 6** Foreign graduate and masters candidates may register for courses in areas related to Biotechnology, holders of a higher education diploma and master's degree.
- **Art. 7** For the application the candidate shall submit, through e-mail (ppgbiotec@ufsj.edu.br), the following documents in digital form:
- I. Application form signed by the candidate (ANNEX II)

- II. Application declaration (ANNEX III)
- III. Passport copy showing the candidate's identification data;
- IV. Copy of Diploma or Undergraduate Course Certificate of Conclusion issued by the Institution from where the degree was obtained, and legally recognized in the country of origin.
- V. Copy of Master's Diploma (or another document indicating the expected date of conclusion) issued by the Institution where the degree was (or will be) obtained and legally recognized in the country of origin.

<u>NOTE:</u> Diplomas presented in languages other than Portuguese, Spanish, English and French must include an official translation to Portuguese.

- VI. Copy of undergraduate and master's transcript.
- VII. Curriculum Vitae.
- VIII. Proof of knowledge of the English language.
- * Proof of knowledge of the English language must be presented by the date of enrollment (in the case of approved candidates).
- * If the candidate does not have proof of Proficiency in English, verification of Sufficiency in English will be carried out by the examining board, at the time of the oral presentation of the research pre-project (stage II of the selection process). If the candidate is not considered suitable, proof of knowledge of the English language must be presented by the date of enrollment.
- IX. Research pre-project in English (electronic version). The document must contain <u>at most</u> 10 pages (including a 48-month schedule). The candidate's name, as well as the advisor's, should not be included in the project. Coding will be used to protect the identity of candidates.

NOTE: Only entries accompanied by all of the documents described in Article 7 will be accepted.

2.2 APPROVAL OF APPLICATIONS AND APPEALS

- **Art. 8** Application requests will be analyzed beforehand by the Biotechnology Graduate Program Board, to verify the fulfillment of the requirements.
- **Art. 9** Approval of applications by the Biotechnology Graduate Program Board will be made available on the Program homepage, on September 24th, 2019.

Single paragraph - Candidates whose applications are rejected may appeal the decision, by sending a claim to the Biotechnology Graduate Program Board, on the day of September 25th, 2019, through the e-mail: ppgbiotec@ufsj.edu.br. **For Appeal decisions, no new Appeals will be allowed.**

3 SELECTION PROCESS AND ASSESSMENT OF CANDIDATES

- **Art.10** The selection of candidates will be made by the Biotechnology Graduate Program Selection Committee, and will consist of 03 (three) stages, which are:
- **I. Stage I (eliminatory and classificatory)** Evaluation of the research pre-project in accordance with the criteria contained in **ANNEX IV.** This stage will be held on September 30th, 2019.
- II. Etapa II (eliminatory and classificatory): Presentation of the research pre-project. The candidate will have a maximum of 15 minutes to present the research project to be developed in the doctorate program, and the examining board will have up to 30 minutes to argue the candidate regarding the pre-project. This stage will be recorded. For the purpose of evaluating the pre-project presentation, the criteria defined in ANNEX V of this call will be considered. This stage will be held on October 4th, 2019. The presentation will be made by videoconference at a time to be defined later, according to the time availability of the candidate and the board.
- **III. Stage III (classificatory):** evaluation of Curriculum Vitae.
- §1 In each of the stages (Stages I, II and III), scores will be given in the evaluation from 0.0 (zero) to 10.0 (ten) points.
- § 2 Candidates that receive a score greater than or equal to 6.0 in Stage I will be eligible to complete Stage II.
- § 3 Candidates that receive a score greater than or equal to 6.0 in Stage II will be eligible to complete Stage III.
- §4 The place and time for the completion of Stage II will be disclosed on the Program homepage.
- §5 In stages I and II, candidates will have their identities protected, with each candidate being identified by a code.
- Art. 11 Candidates that receive a score greater than or equal to 6.0 (six) in stages I and II will be considered approved.
- § 1 The final score (FS) for candidate classification purposes will be calculated by the simple sum of the scores received in stages I, II and III.
- § 2 The candidate may be approved, but not selected, depending on the number of vacancies made available by each adviser in accordance with Article 1 of this Call.
- **Art. 12** The candidates will be selected by descending order of classification, according to the final score, and according to the number of offered vacancies by each PPGBiotec adviser.
- § 1 If there is not a sufficient number of approved candidates to fill the vacancies offered by the adviser, there may be unfilled vacancies at the end of the selection process.
- § 2 If the candidate is approved but does not have the necessary classification to be appointed to the indicated advisor, the relocation of candidates to a new advisor will be allowed, if there is an agreement between both parties and if the new advisor has not filled yet the number of vacancies offered in this Call

4 RESULTS AND APPEALS

Art.13° The Biotechnology Graduate Program Selection Committee will disclose the results of Stage I on the day of October 1th, 2019, Stage II on October 10th and Stage III on October 14th. The candidate may appeal the result of any stage, by a signed and digitized claim to be submitted by e-mail to ppgbiotec@ufsj.edu.br, addressed to the Biotechnology Graduate Program Board, within 48 hours of the disclosure of the result of this stage. For Appeal decisions, there will not be new Appeals.

5 APPROVAL OF THE FINAL RESULT

Art. 14 The final result will be approved by the Selection Committee, and will be disclosed by the Program Secretariat at Centro-Oeste Dona Linda *Campus*, on the Program *homepage*, on the day of October 15th, 2019.

6 ENROLLMENT AND COURSE START

- **Art.15** The candidates who are approved and classified by the advisor will have the right to enrollment, respecting the established vacancy limits in Article 1 of this Call.
- **Art.16** The enrollment of selected candidates will be made in the Secretariat of Coordination of the Biotechnology Graduate Program, according to UFSJ Graduate calendar, available on the program page.
- §1 At the time of enrollment, the candidate shall present all original documents submitted in digitized form, in addition to the <u>Brazil residence visa and Travel Insurance</u>. If the original documents, the visa and Travel Insurance are not presented, the candidate will not have his/her enrollment processed. There can be no pending submission of documents.
- §2 In case of cancelled enrollment, there will be a summon for approved candidates, considering the order of classification by each advisor..

7 FINAL PROVISIONS

- Art. 17 The Biotechnology Graduate Program will not make available for foreign students Program scholarships received from Brazilian national funding agencies. If approved, the candidate must have the financial means to stay in Brazil throughout the entire doctorate period. The candidate must also provide his/her Brazil residence visa and present it at the time of enrollment.
- **Art. 18** The application of the candidate will imply the knowledge and acceptance of the rules and conditions established in this Call.
- **Art. 20** Candidates will be excluded from the selection process in the following cases:
- I. Missing a stage of the selection process;
- II. Displaying behavior considered incompatible with the standards of the process, to exclusive criterion of the Selection Committee.
- **Art. 21** The selection exam will only be valid for the Program that begins in **2020**.

- **Art. 22** Changes related to the dates and times of exams, program content and scoring will be published by the same means used for the disclosure of this Call.
- **Art. 23** Candidates registered in the selection process shall recognize and accept the rules established in this call, in RESOLUTION No. 042 of October 2nd, 2012 (Modified by Res. 035/2014) CONSU/UFSJ and in the regulations of the Graduate Program to which they have applied.
- **Art. 24** In order for candidates with special, temporary or definitive needs to participate in the selection process, a confirming medical report must be presented at the time of application. The use of hearing devices will only be allowed for those candidates who have proof of hearing needs at the time of application (medical report). The device may only be used at times determined by the board, when verbal communication is required.

Art. 25° Any omissions in this Call will be resolved by the Biotechnology Graduate Program Selection Committee.
