2. Biosciences Applied to Pharmacy and Rational Use of Medicines: This research line includes experimental and clinical studies aimed at diagnostic, epidemiological, and therapeutic investigations, including the evaluation of molecular and biochemical biomarkers; studies on the use of medicines; effectiveness and safety of drugs; evidence-based practice; pharmaceutical care; pharmaco-economics; pharmacovigilance; pharmaceutical services, and education.
